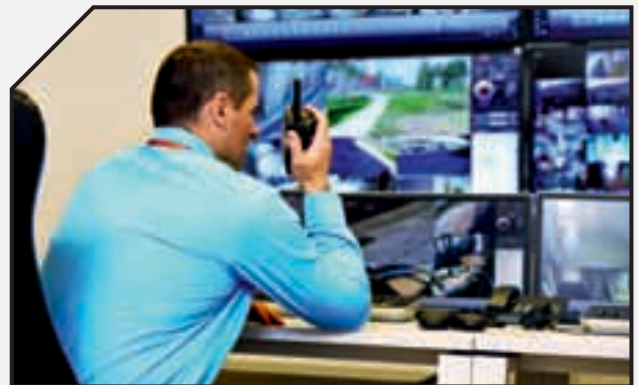
1. To check all in and out going materials and maintain proper records.
